- 1. <u>CALL TO ORDER & AGENDA Accepted as presented.</u> P. Ruess called meeting to order at 6:00PM.
- 2. **PUBLIC COMMENT PERIOD** No members of the public commented.

## 3. CONSENT AGENDA –

• Minor changes made to the April 16, 2025, Board Meeting minutes that board members sent separately before the meeting.

- 4. 2024 CSWD Household Survey J. Holliday introduced Michael Moser from UVM Center for Rural Studies, who conducted the household survey with his team in December 2024. J. Holliday said that since the 1990's CSWD has generally conducted surveys every two years. M. Moser provided an overview of the purpose, methods, and highlighted key points. The survey was conducted online in 2024, utilizing email addresses of Chittenden County residents with about 1800 respondents. Demographics show that more respondents are homeowners and held higher education levels than average rates in the county. He noted that the majority of respondents (~70%) primarily dispose of trash with a hauler. 85% of respondents have used a drop off center (docs) and 95% said they were very or somewhat easy to use. He outlined reasons why others did not use a DOC, which included: limited hours, distance, lines, no transportation. He reviewed a graph, which shows respondent's awareness of the DOCs accepted materials. J. Holliday said CSWD will use this data, coupled with the Waste Characterization study that the State of Vermont conducted, to prioritize education on specific materials that can be diverted from the landfill. Respondents had varied preferences on how to receive information from CSWD – email, website, Front Porch Forum, mail, etc. Board members asked questions following the presentation. Discussion was held on plastic film with a question on whether CSWD would consider collecting it. J. Holliday said that CSWD did consider this for upcoming budget year but was not able to pursue due to budget reasons.

S. Reeves explained the nomination process and deadline, including further clarification of the role of the Executive Board and other openings, and who eligibility for positions on the Board.
